Why?	Financial companies choose how they share your personal information. Federal law gives consumers the right to limit some but not all sharing. What?	 The types of personal information we collect and share depend on the product or service you have with us. This information can include: Social Security number Account balances, payment history and loss history Credit history and credit scores 		
	When you are <i>no longer</i> our customer, we continue to share your information as described in this notice, e.g. information on a paid loan with a credit bureau.		
How?	All financial companies need to share customer's personal information to run their everyday business. In the section below, we list the reasons financial companies can share their customer's personal information; the reasons Bank of Utica chooses to share; and whether you can limit this sharing.

Definitions	
Affiliates	 Companies related by common ownership or control. They can be financial and nonfinancial companies. Bank of Utica has no affiliates
Nonaffiliates	 Companies not related by common ownership or control. They can be financial and nonfinancial companies. Bank of Utica does not share your personal information with any nonaffiliates
Joint marketing	 A formal agreement between nonaffiliated financial companies that together market financial products or services to you. Bank of Utica does not do so
